2 Minutes of the Annual General Meeting November 6th 2017

The minutes of the previous meeting, having been circulated, were taken as read and adopted as a true record. Proposed by Chris Fletcher and seconded by Susan Brown. The Minutes were signed by the Chairman as a true record.

3 Matters Arising.

Pre AGM Meeting – arranged and held on 3rd November.

4 Secretary's Report

The Secretary reported that there had been four Executive meetings, a Finance meeting a Representatives meeting & four Lincolnshire Partnership meetings. Clubs were reminded to advise the Secretary any changes to their Lady Secretary, Club Delegate, Captain and Handicap Secretary. The Secretary handed over to Elaine Lilley to outline the efforts made to improve communication between clubs and County.

Mrs Lilley reported that the aim is to increase contact with clubs, increase participation in County events and bring more girls and women into golf in Lincolnshire. The objectives are to maintain contact with clubs, create a register of named contacts and engage clubs into dialogue with the Association over relevant issues. The past few months have seen the production of a newsletter and in order for it to be sent to individuals, consent is needed. Members were asked to complete a GDPR registration form, which can be downloaded from the website. Clubs were asked to continue sending articles for inclusion in the newsletter.

5 Treasurer's Report

Mrs Ireland began by reporting that the association has a healthy financial position despite a deficit of £2604 and the Lincolnshire affiliation fee will remain at £6.50. The England Golf levy will be £9.00 from 1st November 2018, an increase of 75p.

There are 2401 members, down by 75 from 2017, which represents a 3% decrease. County competitions showed a profit of £885.00 and the raffles raised £2065.00, with proceeds going to the Juniors.

The support of the following clubs for the Juniors is greatly appreciated: Belton Park, Woodhall spa, Louth, Blankney, Lincoln, Spalding LVLGA and the Lincs Past Club Captains Society.

The Patrons had made a donation of £1000.

6 Lincolnshire teams entered the Taskers Trophy and as a result £300 is due to be received for Junior funds. The competition is run along similar lines to the Mail on Sunday. Details on the Taskers website.

Team kit - shirts, jumpers & umbrellas, were purchased .

The Treasurer also reminded clubs about putting open days on the website for a fee of £15. County Cards – on payment of affiliation fees, members are entitled to a County card, which gives a discount at numerous clubs around the Country.

Thanks were given to Phil Smith for auditing the accounts and to the ladies for their support of the County competitions and raffles.

9 Midland Representative's Report

Miss Scurr reported on her first year as MNR representative getting to know County colleagues and the MN representaives from Derbyshire, Leicestershire & Rutland, Nottinghamshire, Shropshire & Staffordshire, who are all working together to promote Ladies amateur golf, working with England Golf towards this goal. After several debates the England golf affiliation fee has been set at £9.00 , and increase of 75p.

MN events – Lincolnshire were responsible for the Region final of the Australian Spoons. This was held at Burghley Park on 8th August. 42 pairs competed and the winners were Desley Smith and Pam Green (Branston Gold & Country Club) with 44 points. Mandy Lees & Linda Moss (Toft) were third. Angela thanked Dawn, Birdie and Burghley Park Golf Club for all their help. Clubs were asked to encourage members to enter MNR events, all entry forms to be sent out by EG at the beginning of 2019.

10 Handicap Advisor/Liaison Officer's Report

Mrs Macarthy reported that the World Handicapping System is due to start in 2020 and had attended two workshops. A further meeting is on 14th November when more information will hopefully be available.

New R & A rules come into force on 1st January 2019 and player's versions should be available at clubs.

A Guide for Committees has been issued , which has been forwarded to all handicap secretaries. Clubs were reminded to advise either Terry or the Secretary in there was any change in the clubs handicap secretary.

11 Scratch Score Assessor's Report

Mrs Jacobs reported on the progress of the course rating program and explained who and what they do. Along with Di Rafferty and representatives from LUGC, each course is rated on the degree of difficulty from the white, yellow and red tees to establish a 'standard scratch' upon which handicaps are based.

The following courses have been rated: North – Market Rasen, Louth, Elsham, Forest Pines, Waltham Windmill, Canwick Park and Kenwick Park . South – Greetham valley, Boston, Boston West, North Shore, Blankney, Sleaford, Woodhall Spa (Bracken) and Stoke Rochford.

Clubs were asked to ensure that a current measurement certificate, no more than 10 years old, was available prior to the course being rated.

12 League Secretary's Report

The County Handicap League final was played on 12th September at South Kyme Golf Club. The winners of Division 1 North, Elsham B, played the winners of Division 1 South, Toft. The match finished 2-2 and went to sudden death with Toft winning on the first extra hole for the second year running.

Results of the Handicap League are attached to this report.

Division 5 South had only 3 clubs in 2018 and 2 clubs were promoted, Burghley Park have entered a C team. Immingham have withdrawn, Laceby Manor have been promoted to Division 5 North . Cleethorpes have entered a B team, who will join Division 6 North. The Handicap League results have been sent to all participating clubs, together with a list of the 2019 divisions.

Please can team captains ensure the results are sent on the correct result form and not just an email or a mobile photo informing me of who has won and the score, as the full result is needed in the event of a count back of games. The rules for 2019 and result sheets for submission to me will be available to download from the website in PDF. 'Word' versions are available from Barbara Haycox [-secretary@lwga.co.uk](mailto:secretary@lwga.co.uk). or myself. Please make sure you use the up to date forms.

The results pages have been amended ready for 2019 to include the new leagues divisions. Clubs with two or more teams in the league are reminded to **retain a copy of their handicap list for all matches A, B and C teams** should they need to be referred to on the match day or at a later date. **Home team** captains please send results by post or e-mail as soon after the match has been played so that the website can be kept up to date. Would clubs please specify on the result sheet whether it is the A, B or C team result.

Clubs are reminded that the county cannot interfere with individual clubs policies on league matches, only set out the conditions and rules of play. Please make sure you confirm your matches in writing and verbally nearer the date to avoid any confusion.

The league rules were amended last year to state that where possible clubs should offer a weekend date for matches to ensure all members have an opportunity to play in the matches, I would like to reiterate that where ever possible this should be adhered to.

Rule 9 Clubs entering more than 1 team:

- (a) *The teams shall be designated A, B, C. On the date of selection, clubs must refer to the current handicap list of players ranked in order of their exact handicap. Subject to (b) below:*

Players ranked 1-8 can only be considered for the A team.

Players ranked 9-16 can only be considered for the A or B team.

Players ranked 17 onwards can be considered for any team.

- (b) *A player having played for the A team 3 times, may not play for any other team in the Lincolnshire Ladies Handicap Leagues in the same year. A player having played for the B team 3 times, may not play in the C team in the same year. In the case of a dispute, the County League Secretary may request a Master Handicap list for the relevant date. It is therefore essential that Captains retain a copy of the list showing the exact handicaps of the team played on the relevant day*

Rule 16 reminder

Players must walk at all times during league matches, unless permitted to use a golf buggy by the League Secretary. Permission will be given to those players having a current medical condition existing on the day of the relevant match, who have given prior notification to the league secretary and the Opposing team

Captain/Representative. The Association will take each player on trust and will not enquire into the nature of any said medical condition, nor will it require evidence by way of a medical certificate as proof of such a condition.

The buggy shall be for the sole use of the player and her equipment. Hiring of the buggy shall be the sole responsibility of the player. Players are expected to familiarise themselves with the Health and Safety policies of the host club in so far as it relates to ride on buggies.

The final of the Scratch League 2018 was played on September 5th at Holme Hall, Greetham Valley winning 2 -1 against last years winners, Woodhall Spa.

Stoke Rochford and Blankney have withdrawn for 2019 and Belton Park have entered a team in the South Division. If anyone wishes to join the Scratch league in the future please let me know so that we can include any new teams.

Congratulations to the League and Scratch team winners and thanks to South Kyme and Holme Hall for courtesy of their courses, the referees and the support of County officials on both days. Thank you to all the teams who participated in the leagues this season and good luck to everybody for next year.

The County Captain presented the Handicap League Trophy to Toft this year's winners.

13 Captain's Report

Mrs Dawson reported on the pre – season matches activities which included coaching by Paul Spence at Kenwick Park, 1st v 2nd team match played at Seacroft and a match against Lincoln Men which resulted in a loss.

At the County Championships, held at Kenwick Park, half a days play being lost due to the weather which meant the Butlin Trophy was reduced to 9 holes. The winner Lynn Exley, Gedney Hill, was playing in her first County event. Thanks were given to Sue Fisher, Lady Captain and all the ladies from Kenwick Park for their help over the three days.

The 2019 Championships are at Holme hall on the first Bank Holiday in May – Saturday, Sunday and Monday. Members were asked to encourage players to enter not only the Championships but all County events.

The Bronze Championships were held at South Kyme. Thanks were given to all clubs who hosted County competitions.

County Match Week was held at Hollinwell in Nottinghamshire.

13. a.ii – amend wording to **-Two representatives from each Club affiliated to The Association**

13. b.i – amend wording to **-To elect a representative from each of the three County regions, namely North, Central & South, onto the Executive Committee. Delegates may only vote for their respective region..**

17 – delete - **his/her 2nd class return fare and overnight expenses**
